

**ZEDTOWN EVENT – LIFE LIKE TOURING (AUSTRALIA) PTY LIMITED (ACN 140 664 008)
ASSUMPTION OF RISK, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

The ZEDTOWN event is a fun and lively experience for all participants, and is conducted with the core essences of friendly rivalry and non-contact interaction. Venues are part of the challenge and usually involve environments that might include stairs, grassed slopes or other manmade or natural hazards. These will be encountered by the participants, who will engage these hazards as they see fit and appropriate based on their own best sense of their capability and fitness at the time.

TO: Life Like Touring (Australia) Pty Limited (including its directors, employees, principals, agents and independent contractors), (collectively referred to as “LLT”): I confirm the following is true and correct and that LLT has relied on my answers in allowing me to participate in the ZEDTOWN event (the “Event”).

In consideration of LLT permitting me to participate in the Event:

Name and Likeness Release I hereby grant permission to the Event organisers, their successors and sponsors to use my name, image and likeness in direct connection with the Event for promotional broadcasting or reporting purposes in any and all manner and media, unless restricted by Privacy Laws.

Express Voluntary Assumption of Risk I understand that I, and each participant in the Event, will be engaging in activities involving a real risk of serious injury or even death from various causes including but not limited to equipment failure, accidents with other participants, spectators, course or weather conditions or other causes. I voluntarily accept all risks necessarily flowing from my participation, which could result in loss of life or injury.

Liability Release and indemnity I hereby release LLT and all persons or corporations associated directly or indirectly with the conduct of the Event from all claims, demands and proceedings arising out of my participation and hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my participation in the Event. This release shall extend to and include LLT and the Event organiser, partners, managers, officers, agents, contractors, any club, organisation and volunteers including medical and paramedical personnel appointed for the Event, the owners, licensees, and occupiers of land on which the activities or any part of it are conducted or which is involved directly or indirectly with the Event in any manner whatsoever and promoters, sponsors and activities organisers (the ‘Released Parties’). This release and indemnity continues forever and binds my heirs, executors, personal representative and assigns. This waiver and release specifically excludes the Released Parties from liability for ordinary negligence in the conduct of the Event and the application of any of the provisions of Subdivision B of Division 1 of Part 3-2 of the Australian Consumer Law and the Released Parties shall be excluded from liability under any civil liability or consumer law applicable to the State in which this Event is held, to the extent permitted by law and by the relevant consumer laws.

Physical Fitness I am physically fit to participate in the Event in which I have chosen to participate and have not been advised otherwise by a medical practitioner. I understand that it is my responsibility to monitor my physical condition during the Event, and I agree to withdraw immediately and to notify appropriate personnel if at any point my continued participation would create a risk of danger to myself or to others.

Medical Treatment I consent to receiving any medical treatment (e.g. first aid) that LLT considers reasonably necessary during or after the Event. I agree to assume all costs of emergency medical care and transportation.

Alcohol & Drugs I certify that I am not, and on the date of the Event will not be, under the influence of alcohol or any non-prescription drugs that would in any way impair my ability to safely participate in the Event. I further understand that the consumption any alcohol and any illicit or illegal drugs or substances during the event is strictly prohibited. The consumption of any alcohol, illicit or illegal drugs or substances before, during, and after the Event is strictly prohibited.

I have read this document and fully understand its contents. I understand that I am giving up substantial rights, including my right to sue. I further acknowledge that I am signing this document freely and voluntarily.
